#### **GENERAL COMMUNICATIONS**

Primavera Arvizu, Dean of Student Success, introduced Jennifer Strobel, the new Director of Admissions and Records. Severo Balason, Jr., Vice President of Student Services, introduced Kevin Altenhofel, the new Director of Campus Safety.

# PRESENTATION - Guided Pathways

Primavera Arvizu, Dean of Student Success, presented a PowerPoint update on the framework being developed by College Guided Pathways workgroup (copy attached to official minutes). The collective effort is making progress in creating predictive pathways that would allow colleges to offer students the courses and resources they need to complete educational goals on time and efficiently. Focuses in developing Guided Pathways includes the self-assessment of the abilities expected from the College, integration of data to determine what efforts are effectively making a difference, and educating the student in their role to develop and follow educational plans. Dr. Daniels thanked Ms. Arvizu and the workgroup participants for the work included in developing the detailed framework. She also thanked Ms. Arvizu and congratulated her on her promotion to the Vice President of Student Services at another California Community College.

# APPROVAL OF MINUTES

On a motion by Trustee Long, seconded by Secretary Campos and unanimously carried, the minutes of the Regular Meeting held March 14, 2018 were approved.

#### **NEW BUSINESS**

Second Presentation and Request for Approval - Tentative Agreement Between Taft College Faculty Association (TCFA/CTA/NEA) and West Kern Community College District (WKCCD) - Faculty/Adjunct Faculty Employee Data and New Employee Orientations (AB 119)

Dr. Daniels reported that the agreement will bring the District into compliance with legislation and is a joint effort to bring union participation into the onboarding process. On a motion by Trustee White,

seconded by Trustee Orrin and unanimously carried, the agreement was approved (copy attached to official minutes).

Second Presentation and Request for Approval - Tentative Agreement Between Taft College Faculty Association (TCFA/CTA/NEA) and West Kern Community College District (WKCCD) - Proposed Compensation and 100% Release Time for Academic Senate

Dr. Daniels explained that the Academic Senate release time has been reviewed by the bargaining committee. Data showed that the current release time was not comparable to like-sized colleges and the committee agreed to raise the release time to 100 percent. On a motion by Trustee Long, seconded by Trustee Orrin and unanimously carried, the agreement was approved (copy attached to official minutes).

Second Presentation and Request for Approval - College and Career Access Pathways (CCAP) Agreement with Taft Union High School District (TUHSD)

Dr. Daniels stated that this agreement is a renewal of the CCAP agreement that will conclude in June with TUHSD. This is a one-year agreement. On a motion by Trustee Orrin, seconded by Trustee Long and unanimously carried, the CCAP agreement was approved (copy attached to official minutes).

Request for Approval - Request for Approval to Proceed with the G Buildings Door Hardware Phase One Project with Convergint Technologies, \$28,538.08

Dr. Daniels reported that this project would update the G buildings to the passcard lock system. Brock McMurray, Executive Vice President of Academic Affairs, added that this update would increase the security of the buildings and that the passcard system does bring long-term savings to the District. On a motion by Trustee Campos, seconded by Trustee White and unanimously carried, the project was approved (copy attached to official minutes).

# **Trustee Reports**

Trustee White reported that the Board attended the Association of Community College Trustees Governance Leadership Institute in San Antonio, Texas. The conference was educational and included campus visits near San Antonio. He is proud of the work being done at Taft College following the conference and campus visits.

President Cole echoed the commendation of the work being done at Taft College. She also recognized the effort and work completed by Guided Pathways workgroup in completing the plan. President Cole also recently participated in the Taft Union High School Honors Night. The College honored 78 seniors with the Taft College Merit Award.

# **Associated Student Organization**

Student Trustee Kayla Meyer reported events in planning with the upcoming Spring Fling week and a spring ASO trip to Disneyland. The ASO will also be celebrating Faculty Appreciation week with a variety of events. Students will be able to have a snack from ASO officers during finals. Also underway are ASO officer elections and a constitution review.

Focus group efforts brought in 23 students, each offering feedback in areas such as high school students taking transferable courses, the transfer process, and unique positive characteristics at Taft College. The next focus group will be held May 8<sup>th</sup> and will be concentrated on the student athlete population.

#### **Academic Senate**

Diane Jones reported on behalf of the Academic Senate (AS). First, she stated that the AS members thank the District and Faculty bargaining group for agreeing on an increase in release time for the AS officers. Ms. Jones then reported that the Senate of the Whole approved the annual report to ACCJC, changed the language of the computation institutional Student Learning Outcome to align with language in California State University breadth pattern, and recommended that the District update Board procedure AP 5011: Special Admit Procedure to be revised so that the age limit for students be removed and the instructor signature no longer be required.

#### **Administrative Services**

Brock McMurray, Executive Vice President of Administrative Services, told the Board that the Student Center steel structure is in phase four of five. He also reported that the Business Services department is focused on preparing for the 2018/19 budget with new unknown parameters from the State. Staff are building a conservative budget in anticipation of formula changes being determined by the Governor, which will be announced in May.

#### **Human Resources**

Julie McNeil, Interim Associate Vice President of Human Resources, updated the Board that many of the key positions that are currently vacant are now in the selection process.

#### **Student Services**

Severo Balason, Jr., Vice President of Student Services, recently attended a ceremony honoring Phi Theta Kappa award winner Cyerra Davis. He stated that the event was wonderful and inspiring the students who were recognized. Mr. Balason reminded the Board that the Al Baldock Golf Tournament is soon. At present time, there are 20 teams signed up to participate in the event.

# **Information Services**

Andrew Prestage, Executive Director of Information Services, told the Board that the department recently conducted a phishing test to bring awareness to the issue to employees. He also told them that the update to internet bandwidth is coming very soon.

#### **Student Success**

Primavera Arvizu, Dean of Student Success, stated that she is currently working the Admissions and Records department to ensure a smooth transition. She thanked the Board and the College staff for the opportunity to serve the District.

# **WESTEC**

Bill Rector, Executive Director of WESTEC, reported that this has been a fruitful full time equivalent (FTE) year. He also shared that five court reporting students are awaiting their state test dates and 16 more students are nearing meeting the standards to take the test as well.

# Transition to Independent Living

Carey Carpenter, Interim Director of TIL, thanked the community and campus for their continued support of the program. With collected efforts, TIL had a successful 20 year reunion celebration. She added that there will be a TIL team at the golf tournament which will be comprised of staff and students. Ms. Carpenter also reported that the program is beginning the process to transition students home and also recruiting the next TIL class. TIL is honored and excited to also participate in the Give Big Kern fundraising event with the support of the TC Foundation.

# **Institutional Research & Planning**

Oleg Bespalov, Executive Director of Institutional Research & Planning (IR), stated that the IR department is developing the ACCJC midterm report and will present it to the Board in September. The IR staff are also working with College staff to complete the Annual Program Review step to rank non-personnel requests and personnel requests in their separate processes.

#### **Foundation**

Javier Reyes, TC Foundation Development Officer, said that the Foundation hosted Wounded Heroes on campus and are networking to improve resources/opportunities to Veterans on campus. Foundation staff are working developing a Grad Summit event with alumni returning to speak to graduating students regarding the experience with TC and how to continue their educational and career goals. The College had a visit from Assemblyman Vince Fong and also from Chevron's Adam Alvidrez. The support from the community and elected officials continues to benefit College programs and students.

Dr. Daniels stated that this year there were 78 honorees at Taft Union High School that received the TC Merit Award Scholarship. She added that the event is a nice opportunity to see the impact of the relationship between the two schools and the opportunity it gives students.

# State of the City

Dr. Daniels was one of the community speakers at the annual State of the City luncheon. She was grateful to speak and was pleased with the information shared by other presenters in regards to other topics/issues shared with community stakeholders.

# Other

Currently Dr. Daniels is observing adjunct faculty and is pleased to have the opportunity to meet many of our adjunct instructors. She also noted that the end of year events are about to begin and many staff are working in preparation of these events.

# Background:

California Education Code § 42141 requires school districts to publicly disclose certain information that affects their financial status. Section 42141 specifically addresses workers compensation funding for districts that are self-insured, either individually, or as part of a joint powers agency (JPA). It also provides, in pertinent part, that the district superintendent shall annually provide information to the governing board regarding the estimated accrued but unfunded cost of worker's compensation claims.

West Kern Community College District is a member of Self-Insured Schools of California (SISC). An actuarial study was completed by Aon Risk Consultants, Inc. of the financial standing of SISC as of December 31, 2017. The actual financial position as of February 28, 2018 was \$38,904,847. The projected financial position on June 30, 2018, is \$36,948,726. These figures show that SISC ended positive financially and we are in full compliance with sufficient reserves.

Education Code 42141 requires school districts and county offices of education to publicly disclose certain information that affects their financial status. This legislation requires the following public disclosure:

If a district is self-insured for workers' compensation claims, either as an individual district or as a member of a joint powers agency, the district superintendent shall annually provide information to the governing board regarding the estimated accrued but unfunded cost of those claims. The estimate is to be based on an actuarial report obtained at least every three years. The information shall be presented by the superintendent at a public meeting of the governing board, and at that same meeting the board shall disclose, as a separate agenda item, whether or not it will reserve a sufficient amount of money in its budget to fund the present value of the accrued but unpaid workers' compensation claims or it is otherwise decreasing the amount in its workers' compensation reserve fund. The board will annually certify to the county superintendent the amount of money, if any, that is has decided to reserve in its budget for the cost of the benefits and/or the claims, and submit any necessary budget revisions to account for that reserve.

The actuarial study performed by Aon Risk Consultants, Inc. representing SISC's projected financial position as of June 30, 2018 is summarized in the following table.

I am pleased to report that, as the actuarial summary shows, the SISC I - Workers' Compensation JPA has a positive ending financial position. The ending balance includes sufficient reserves to enable your district to be in full compliance with the workers' compensation portion of Education Code 42141 without making any excess contributions to the SISC I JPA.

Please share this information with your governing board and retain a copy of this memorandum for your district's auditors. SISC will send a letter to your county superintendent confirming that your district is in compliance with the workers' compensation portion of Education Code 42141.

This agreement will amend the original subcontract with West Kern Community College District. The following items will be amended:

- 1) *Item I.C. Scope of Work*. The addition of Exhibit G Chancellor's Office Memorandum Dated July 28, 2017: Strong Workforce Program District and Region Allocations for Round 2: 2017-18; addition of Exhibit H Chancellor's Office Memorandum Dated January 1, 2018: Strong Workforce Program Positive Incentive Funding for District and Region Allocations for 2017-18; and the addition of Exhibit I SW2 CRC College Regional Share Allocations.
- 2) *Item II. Term of Agreement*. The Expiration date of Agreement will be amended from December 31, 2018 to December 31, 2019.
- 3) *Item III. Rules for Funding*. The addition of *I*, "In the event that the Chancellor's Office and the CRC jointly determine that sufficient progress has not been made on an approved SWP regionally funded project(s), the Steering Committee may direct the reallocation of a portion the Contractor's funding to another contractors' regional project(s). Likewise, a Contractor may voluntarily reallocate a portion of their funding to another regional project."
- 4) *Item IV. Participation Agreement Payments and Invoicing. B.* Language to be inserted after the first sentence—"In addition, the District shall also make payments to the Contractor of up to an additional \$325,334 which totals the West Kern Community College District's share of the SWP SW2 CRC Regional Share per the allocation agreement ratified by the CEOs of all colleges/districts in the region.

- 5) *Item IV. Participation Agreement Payments and Invoicing. C.* The invoicing period for SW2 will be effective from July1, 2017 to December 31, 2019; District must receive final invoices for SWP2 no later January 15, 2020 and SW1 remains at no later than January 15, 2019, unless agreed to otherwise by the District and/or the Chancellor's Office.
- 7) *Item V. Reporting*. Replace entire sentence with the following: "Contractor shall prepare and submit Regional Share project applications with appropriate metrics identified, as well as progress and financial reports as required by the Chancellor's Office and/or the District Project Director/manager (CRC Regional Chair) via the Chancellor's Office NOVA reporting portal unless specified otherwise."
- 8) Item VII. Records/Audit. D. December 31, 2018 shall be replaced with December 31, 2019.

In all other respects, the Subcontract is reaffirmed.

- Increase by at least 20 percent the number of CCC students annually who earn degrees, credentials, certificates or specific skill sets to prepare them for an in-demand job;
- Increase by 35 percent the number of CCC students transferring annual to a UC or CSU;
- Decrease the average number of units accumulated by CCC students earning associates degrees, from approximately 87 total units (the most recent system-wide average) to 79 total units – the average among the quintile of colleges showing the strongest performance on this measure;
- Increase the percentage of CTE students who report being employed in their field of study from 60 to 69 percent – the average among the quintile of colleges showing the strongest performance on this measure;

- Reduce equity gaps across all of the above measures through faster improvements among traditionally underrepresented student groups, with the goal of cutting achievement gaps by 40% within 5 years and fully closing those achievement gaps within 10 years.
- Reduce regional achievement gaps across all of the above measures through faster improvements among colleges located in regions with the lowest educational attainment of adults, with the ultimate goal of fully closing regional achievement gaps within 10 years.

Attachment A outlines a breakdown of Local Share and Regional Share allocations for 2017-18.

The state budget provided \$248 million (i.e., \$236M after the 5% state leadership/operation is removed) as compared to last year's \$200M. However, as required by statute,  $1/6^{th}$  is being held until January 2018 awaiting college's annual MIS data submission that is the basis for calculating the positive incentive as recommended by the  $\frac{17\% \text{ Committee}}{17\% \text{ Committee}}$ . What remained was distributed based on statutory factors, with a 60% local to 40% regional fund split:

- CTE full-time equivalent students 1/3rd
- Unemployed adults 1/3<sup>rd</sup>
- Job openings 1/6th

Attachment A outlines a breakdown of Local Share and Regional Share allocations for 1/6 of the 2017-18 funding representing the positive incentive funding for 2017-18 (March 2018 BOG approval). The amounts are shown by district for the local share 60% allocation, and by region for the regional share 40% allocation. In keeping with statute, Regional consortium positive incentive funding is still intended to fund regionally prioritized projects and programs that meet the needs of local and regional economies, as identified in regional plans and Workforce Innovation and Opportunity Act (Public Law 113-128) regional plans [88824 (c)(2)].

- Launchboard will update the Strong Workforce Program tab on March 1, 2018, provide college level totals, and provide workshops to help connect colleges to the outcomes.

#### Taft College Child Development Center

#### **Program Evaluation Proposal**

March 15, 2018

A third-party independent evaluation of Taft College's Child Development Center (CDC) has been requested to gain insight into four areas of program and administrative management. These areas with their guiding questions are as follows:

- 1. **Curriculum:** Is the curriculum design and implementation process at the CDC happening in a DAP manner? What type of curriculum is being used based on program philosophy? What learning opportunities occur to provide staff with outlets to obtain current field-related knowledge?
- 2. Facilities: Are the CDC facilities adequate for its type of program?
- 3. **Teaching ratios and staffing:** Is the CDC staffing being maximized and being used in the most efficient and effective way possible?
- 4. **Budget**: Is the CDC program budget fiscally sound? Are there hidden opportunities that if found and acted upon, could strengthen the program, financially?

An evaluation report will include findings, and analytical considerations and recommendations for the four above evaluated areas and will be given to the client at the project's completion. In order to create an objective evaluation, there are eight modes of quantitative and qualitative information gathering that has been identified. Other areas not identified in the eight areas below may emerge during the evaluation process to support the project. The below areas are in rough order of tasks to complete:

- 1. Conduct a full program tour with the Director with a Q/A session after the tour.
- 2. **Observe each indoor and outdoor classroom environment.** Observables may include (but not limited to) environment set-up and materials offered, curriculum planning and delivery methods (teaching style), discipline techniques and behavior plan protocols, social-emotional supports, health and safety measures, meal service, family partnership elements, and relationships between all members of staff. Video recordings may be used for a portion of the observations.

- 4. **Review coaching cycles and coaching plans** from the 2015-17 QRIS and all other items that the director and teachers are currently being coached on.
- 5. **Conduct an in-depth PAS** on the whole program. The PAS provides valuable information to directors about the quality of their administrative practices and can be used as a springboard for program improvement efforts.

- 6. Interview the Director, the 2<sup>nd</sup> in-charge admin, as well as a member from each classroom. The interviews are meant to capture information pertaining to (but not limited to) all aspects of the curriculum, professional philosophy, relationships, planning time, staffing schedule, and time management. An interview with the Child Development Department Chair will be requested, since lab students are utilized as part of the CDC's staff.
- 7. Full program fiscal audit to lead to a summary of suggested cost-effective business practices and/or identified areas that are in need of more financial support.

1. <u>Services.</u> MBS shall provide Store printed textbooks, solely on a consignment basis for individual retail customers of the Store's campus or online bookstore ("Books"), as part of a publisher's consignment program ("Program") pursuant to this Agreement and the terms and conditions set forth in the exhibits attached hereto. Each exhibit is subject to change by MBS without prior notice to Store, and Store's continued participation in the relevant Program shall constitute Store's acceptance of the revised terms thereof. "Students" shall refer throughout this Agreement to the individual customers of the Store who rent Books as part of the Program.

Store acknowledges MBS is providing the Books solely for individual, personal, non-commercial and non-transferable use and only to individuals with credit card or other form of payment with sufficient information and authorization on file with Store to cover any potential damaged, non-return or extension fees and penalties. Upon prior approval from MBS, Store may collect consignment fees from institutional departments that are renting Book titles for the personal, non-commercial and non-transferable use of individual students for a single term or semester.

Store acknowledges and agrees each Book is and remains the property of the publisher, and Students may use the Books only for a limited amount of time such that at the end of the consignment period, Students will lose all rights to the Books on consignment to them and shall be required by Store to return all such Books to Store. Store further acknowledges and agrees that under no circumstances shall (a) Books provided to Store under the Program be sold or modified in any way without prior written consent or (b) it provide in any way any individual chapters, extracts or pages of the Books (Books shall only be rented on a standalone, complete basis).

Store acknowledges and agrees it will source all inventory for titles covered under this Agreement solely from MBS and not from any other source, including but not limited to the publishers supplying the Books.

Under no circumstances whatsoever shall the Books or the proceeds thereof be subject to the claims of Store's or a third-party's creditor. Store will not in any manner attempt to or encumber, assign, or grant a security interest in any of the Books provided to the Store under the Program, and any attempt by Store to do so shall, without more, constitute a material breach of this Agreement.

Notwithstanding anything else in this Agreement to the contrary, (a) MBS reserves the right to remove a particular Book title from the Program at any time in accordance with the notice provisions herein and (b) nothing herein is intended to or shall so require MBS to maintain any particular Book in its inventory to fulfill any order by Store.

- 2. <u>Store Obligations</u>. Store shall handle all Student-facing consignment transactions for the Books, including but not limited to entering into consignment contracts with each individual Student, charging Students the consignment fees (and penalties if required) in accordance with the exhibits, tracking consignment periods, managing and collecting Book returns, removing abused Books from consignment inventory, and returning overstock Books to MBS as well as inventory when requested by MBS.
  - a) Sales Taxes. Store shall charge Students the appropriate sales taxes on all consignments, buy outs, and deliveries of Books under this Agreement (in accordance with its standard practices and procedures for textbooks and course materials outside the Program) and shall pay such sales taxes on an aggregate basis to the appropriate taxing authorities on a timely basis. Store also shall maintain all data necessary to demonstrate the accuracy of its sales tax calculations and remittances made pursuant to this Agreement until at least the end of the fourth calendar year after the calendar year that includes the applicable calculation and remittance. With respect to any audit of sales taxes or an audit of Store, MBS, or the publisher in relation to sales taxes calculated and remitted under the Program, Store shall (a) cooperate with MBS and the publisher and shall provide MBS with any additional data it needs to respond to the audit with respect to the transactions under this Agreement, and (b) indemnify MBS with respect to any breach of its covenants and obligations under this section. Each party agrees to provide and make available to the other party any resale or direct pay certificates, other exemption certificates, or information reasonably requested by either party related to sales taxes.
  - b) Removal of Inventory. Should a publisher remove or recall titles included in this program, MBS will require Store to return all copies to MBS within the lesser of thirty (30) days of written notification from MBS or fifteen (15) days after check-in at the Store for any copies still considered active rentals in a Student's possession when notification is received from the publisher.
  - c) Audits. Store shall keep complete and accurate accounting records in accordance with generally accepted accounting principles to support and document all charges made with respect to the Books delivered hereunder. Store shall retain such records for a period of at least three years after delivery of the Books.
  - d) Risk of Loss. Store is solely responsible for the full replacement cost value of all Books in its possession or control during the term of this Agreement.
  - e) Damage to Inventory; Reporting. Store also shall ensure it protects the Books from loss or damage using no less than a commercially reasonable degree of care. Store shall provide MBS prompt notice (by telephone (800-325-0530) or email (cserv@mbsbooks.com) in case of loss or damage to any Books provided to Store under the Program, whether by fire, water, or similar causes. Store will take prompt action to assist MBS in determining the amount of any such loss and will furnish MBS with all necessary information for insurance and other purposes.

Store grants MBS the authority to extract inventory, rental, and fee transaction data related to Books through current interfaces (if possible). If there are no data interfaces available, Store agrees to provide MBS, on a weekly basis, the following information, which MBS may modify from time to time:

- f) Data Security. Store acknowledges, in connection with its consignment of Books under this Agreement, it (i) is solely responsible for the security of any cardholder data it receives from a Student, (ii) is familiar with the Payment Card Industry Data Security Standards regarding cardholder data and agrees to comply with those standards in its handling of any cardholder data it receives, and (iii) will not hold any cardholder data on behalf of MBS. Store shall not share any personally identifying information, whether of consignment customers or otherwise, with MBS under this Agreement at any time.
- 3. <u>Financial Terms</u>. Store shall pay MBS the fees in the exhibits within fifteen (15) days of receipt of an invoice from MBS. Students who do not return Books in a reusable condition will be charged a minimum of the fee as described in the exhibits, and Store will pay MBS the full fees described in the exhibits.
- 4. <u>Term and Termination</u>. This Agreement shall commence on the Effective Date and shall continue in full force and effect until terminated in writing by either party upon thirty (30) days prior written notice. Notwithstanding the foregoing, MBS shall have the right to terminate this Agreement, or any Program, immediately upon the material breach by Store of any of its obligations herein or in the event of a levy or other legal process upon the Store's inventory.

Following any termination of this Agreement, Store shall no longer be entitled to take and fulfill customer orders for Books. Following any termination of any Program, Store shall no longer

be entitled to take and fulfill customer orders for Books under such Program. Should any Books be in the possession of Store or any of its customers at the time of termination of this Agreement or a particular Program, Store may retain the Books through the end of the then-current consignment period. Immediately upon the end of such period, Store shall return all Books to MBS in accordance with this Agreement. Store also shall comply with all of MBS' instructions regarding the disposition of all Book inventory at Store. The terms and conditions of the Agreement, including all of Store's obligations hereunder, shall continue to apply with full force and effect until the consignment periods of outstanding Books expire and returns are processed.

5. Warranties; Limitations of Liability. TO THE EXTENT PERMITTED BY LAW, AND EXCEPT AS EXPRESSLY STATED IN THIS AGREEMENT, MBS MAKES NO WARRANTIES, CONDITIONS, GUARANTEES, OR REPRESENTATIONS AS TO MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, IN LAW OR IN FACT, ORAL OR IN WRITING, WITH REGARD TO THE BOOKS, WHICH ARE PROVIDED TO STORE "AS IS". MBS DOES NOT WARRANT THE BOOKS WILL MEET THE STORE'S REQUIREMENTS OR BE ERROR-FREE. TO THE EXTENT PERMITTED BY LAW, MBS SHALL NOT BE LIABLE FOR ANY DAMAGES SUFFERED OR INCURRED BY STORE OR ANY THIRD PARTY ARISING OUT OF ANY INACCURACIES, ERRORS, OR OMISSIONS IN THE BOOKS.

EXCEPT FOR THE PARTIES' INDEMNITY AND CONFIDENTIALITY OBLIGATIONS IN THIS AGREEMENT, NEITHER PARTY SHALL BE LIABLE TO THE OTHER PARTY OR ANY THIRD PARTY FOR ANY SPECIAL, CONSEQUENTIAL, INCIDENTAL, OR INDIRECT DAMAGES OF ANY KIND OR NATURE WHATSOEVER, INCLUDING WITHOUT LIMITATION LOST PROFITS OR GOODWILL, BUSINESS INTERRUPTIONS OR OTHER ECONOMIC LOSS, HOWEVER CAUSED AND UNDER ANY THEORY OF LIABILITY, ARISING OUT OF OR RELATING TO THIS AGREEMENT OR ANY USE OF OR FAILURE TO BE ABLE TO USE THE BOOKS, WHETHER OR NOT ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR WHETHER SUCH LIABILITY IS ASSERTED ON THE BASIS OF CONTRACT, TORT, OR OTHERWISE, AND NOTWITHSTANDING ANY FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY.

6. <u>Indemnification</u>. Each party shall defend, indemnify, and hold harmless the other party and each of its affiliates, and their respective officers, directors, employees, agents, successors and assigns, from and against any claim, demand, action, proceeding, loss, liability, cost, suit, cause of action, damage, and expense (including without limitation court costs and reasonable attorneys' fees) incurred or suffered by or brought against the other party to the extent based on (a) a violation or breach of any provision of this Agreement or any representation, covenant, or warranty contained herein, (b) a party's gross negligence or willful misconduct, or (c) in the case of Store only, any acts or omissions with regard to its provision of consignment services or its policies and practices related to such services and Book distribution.

#### 7. Miscellaneous Legal Provisions.

a) Entire Agreement. This Agreement, and all exhibits hereto, each of which are expressly made a part of and incorporated into this Agreement as they added by the parties, constitutes the sole agreement between the parties, and supersedes any and all other agreements, either oral or written, relating to the Program. Any contrary or inconsistent terms appearing on Store's purchase orders, acknowledgments, or other documents shall not be binding on MBS.

b) Confidentiality. During the term of this Agreement, each party may be provided information that relates to the other party's financial, marketing, or customer information, research, development, business activities, products, services, and technical knowledge. To the extent permitted by law, including any public record disclosure law that may be applicable, all such information (including the Agreement itself) shall be deemed "Confidential Information". Each party may use the Confidential Information of the other party only in connection with the specific duties authorized by this Agreement and shall not, directly or indirectly, use, copy, disclose, or disseminate to any other person or entity any Confidential Information. Each party agrees to protect the confidentiality of the Confidential Information in the same manner that it protects its own confidential information but with no less than a reasonable standard of care. The obligations set forth herein shall not apply to any Confidential Information that becomes known to the public through lawful means and without violation of any law or agreement not to disclose such Confidential Information.

Each party further agrees it shall cause its personnel and representatives to agree to be bound by the terms of this Agreement and be responsible for any of their breach thereof. To the extent legally permissible, each party agrees to notify the other party of any unauthorized use or disclosure of Confidential Information and to take all actions reasonably necessary to prevent further unauthorized use or disclosure. If a party is required by an interrogatory, subpoena, civil investigative demand, or similar process to disclose any Confidential Information, to the extent legally permissible, such party shall promptly provide written notice to the other party so the other party may seek to avoid or minimize the required disclosure or, in the discretion of the disclosing party, waive compliance with the provisions of this Agreement.

- c) Amendments and Waivers. This Agreement may not be modified or amended except by a writing that has been executed by both parties. No express waiver will affect any provision other than that to which the waiver is applicable and only for that occurrence. Failure or delay of a party to enforce any of its rights under this Agreement is not deemed a modification or a continuing waiver by such party of any of its rights hereunder.
- d) Independent parties. MBS and Store are and shall act as independent contractors, and under no circumstances shall this Agreement be construed as creating an agency, partnership, joint venture, or employment relationship between the parties. Unless otherwise provided in this Agreement, neither party nor its employees, agents, or subcontractors has authority to act on behalf of the other party.
- e) **Assignment.** Neither party may assign this Agreement or any of its rights, interests, or obligations hereunder without the prior written approval of the other party. Notwithstanding the foregoing, MBS may assign the Agreement to any affiliate, subsidiary, or successor entity. Any assignment in violation of this provision shall be null and void. This Agreement shall be binding upon and inure to the benefits of the parties' successors and permitted assigns.
- f) Force Majeure. Neither party shall be considered to be in default as a result of its delay or failure to perform its obligations herein when such delay or failure arises out of causes beyond the reasonable control of the party. Such causes may include, but are not restricted to, acts of the state or the United States in its sovereign capacity, wars, insurrections, riots, blackouts, failure of third party communications services,

explosions, earthquakes, lightning, wind, terrorism, viruses, denial of service attacks, sabotage, fires, floods, epidemics, and unusually severe weather.

- g) **Survival.** In the event of any termination of this Agreement, Articles 5 through 7, inclusive, shall survive and continue in full force and effect.
- h) **Notices.** All notices to be given hereunder by either party to the other shall be in writing and shall be effected by personal delivery, by overnight courier or by mail, registered or certified, postage prepaid with return receipt requested, to the addresses in the first paragraph of this Agreement, Attention: Legal.

- 2. IT IS THEREFORE AGREED for in consideration of such agreement that:
- 3. The SUBSCRIBER will set the alarm system for protection required.
- 4. The local protective system at SUBSCRIBER'S premises is not the property of EMERGENCY 24 and said system is to be kept in working order by SUBSCRIBER. #### RESIDENTIAL LEASE

THIS RESIDENTIAL LEASE ("Lease") dated as of [date], is entered into between [name and capacity of landlord] ("Landlord") and West Kern Community College District ("Tenant" or "District").

NOW THEREFORE, for good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

#### Section 1. Lease

Tenant leases from Landlord the premises located at [address], and consisting of [description of leased premises and amenities included in lease] on the terms and conditions contained in this Lease (collectively, "Leased Premises").

#### Section 2. Term

The term of this Lease shall commence on [date] and continue for a period of [number of months].

#### Section 3. Deposit

Concurrent the execution of this Lease, Tenant shall deliver to Landlord a deposit in the amount of [amount] in the form of a District warrant, personal check, cashier's check, or cash ("Deposit"). The Deposit shall be held as security for the performance of Tenant's obligations under this Lease pursuant to Section 14.

#### Section 4. Rent

Rent shall be [amount] per month ("Monthly Rent"), payable in advance, on the first day of each calendar month to Landlord or Landlord's authorized agent, at the following address: [address of landlord or property manager] or at any other place designated by Landlord in writing from time to time. If Tenant takes possession of the Leased Premises on a date other than the first day of a calendar month, the first rent payment shall be prorated in accordance with the then remaining number of days in the month prorated on the basis of a thirty day month (Monthly Rent/30 = daily rent). Rent that equals the amount due for 12 months shall be paid over an 11 month period.

#### Section 5. Utilities, Services, and Yard Care

Tenant shall be responsible for securing accounts in Tenant's name for and the payment of all utilities and services to the Leased Premises, except [list utilities, services, and yard care to be paid by landlord], which shall be paid by Landlord.

#### Section 6. Use and Subletting/Licensing

Landlord acknowledges that Tenant intends to use the Leased Premises as a part of Tenant's Transition to Independent Living ("TIL") program, which consists primarily of housing TIL program students in the Leased Premises as a private dwelling. The use of the Leased Premises

will also include District staff and related parties regularly meeting with TIL program students in the Leased Premises as a component of the TIL program, and other TIL related activities. As a necessary component of the District's use of the Leased Premises, District intends to enter into subletting or licensing agreements with TIL program students ("Students") for the use and occupancy of the Leased Premises for TIL program purposes. Landlord unconditionally consents to such subletting or licensing of all or a portion of the Leased Premises, provided that such subletting or licensing shall not alter Tenant's responsibility for the obligations under this Lease.

Without Landlord's prior written consent, Tenant and Students may not use or maintain a waterbed on the Leased Premises. Tenant and Students may not repair any automobiles or any other motor vehicles, heavy machinery, or equipment, anywhere on the Leased Premises or in or around the building of which the Leased Premises are a part, including the parking area, garage, and driveway. Tenant and Students may not keep or maintain any pets on the Leased Premises without the prior written consent of Landlord, which Landlord may withhold in Landlord's sole discretion.

#### Section 7. Compliance with Law

Tenant shall comply with all laws, statutes, ordinances, and requirements of all city, county, state, and federal authorities now or later in force pertaining to the use of the Leased Premises, and shall require the same of the Students.

#### Section 8. Maintenance and Alterations

Except as set forth in this Lease, Tenant agrees that as of the delivery of possession the Leased Premises are in good working order and repair. Landlord shall, at Landlord's own expense and at all times, maintain the Leased Premises in good working order and repair, including all equipment, appliances, furniture, fixtures, and furnishings. Tenant shall be responsible for damages caused by Tenant's negligence and that of Tenant's family, invitees, subtenants, licensees, and guests. Tenant shall not paint, wallpaper, or otherwise make permanent alterations to the Leased Premises without the prior written consent of Landlord. Tenant shall not commit or allow any person to commit any act resulting in the destruction, defacement, damage, impairment, or removal of any part of the Leased Premises, including wall, ceiling, and floor coverings, and the furniture, fixtures, and furnishings of the Leased Premises. Tenant shall surrender the Leased Premises at termination of this Lease in as good condition as received, normal wear and tear excepted. Tenant shall require Students to comply with this Section.

#### Section 9. Entry

Landlord shall have the right to enter the Leased Premises for the purposes of making necessary or agreed repairs and for showing the Leased Premises to prospective tenants, purchasers, or mortgagees, provided that, except in the case of an emergency, such entry shall be made during normal business hours and upon at least thirty-six (36) hours' prior notice to Tenant. Tenant may not change the locks to the Leased Premises without the prior consent of Landlord.

#### Section 10. Indemnification

Landlord shall not be liable for any damage or injury to Tenant or any other person, or to any property, occurring on the Leased Premises or any part of the Leased Premises or in common areas, unless the damage is caused by the negligent, willful, or intentional act or omission to act of Landlord, Landlord's agents, or Landlord's employees. Tenant agrees to indemnify, defend, and hold harmless Landlord for any liability, costs (including reasonable attorneys' fees), or claims for personal injuries or property damage that is the proximate result of the gross negligence or willful misconduct of Tenant or Tenant's guests or invitees. Each party waives the right of subrogation against the other party.

#### Section 11. Delay of Possession

Tenant may terminate this Lease if possession is not delivered within five (5) days of the commencement of the Term.

#### Section 12. Default and Time to Cure

If Tenant fails to pay rent when due, or to perform any term of this Lease, after not less than seven (7) days' written notice of default given to Tenant in the manner required by law, Landlord, at Landlord's option, may terminate all rights of Tenant under this Lease, unless Tenant, within the time specified, cures the default.

#### Section 13. Remedies

If Tenant defaults, Landlord may elect to:

- (a) continue the lease in effect, and enforce all Landlord's rights and remedies under this Lease, including the right to recover the rent as it becomes due, or
- (b) at any time, terminate all of Tenant's rights under this Lease, and recover from Tenant all damages Landlord may incur by reason of the breach of the lease, including the cost of recovering the Leased Premises and including the worth at the time of the termination or at the time of an award if suit is instituted to enforce this provision, of the amount by which the unpaid rent for the balance of the term exceeds the amount of the rental loss that Tenant proves could be reasonably voided.

In addition to any other rights and remedies allowed by this Lease or by law, Landlord shall have the remedies as set forth in Civil Code §§ 1951.2 and 1951.4.

#### Section 14. Security Deposit

Tenant is placing a Deposit with Landlord in the sum set forth in Section 3. Landlord shall not be obligated to pay interest on the Deposit. Landlord will hold the deposit for the full and timely performance by Tenant of Tenant's obligations under this Lease, including payment of rent and cleaning, maintaining, and repairing the Leased Premises after surrender. If all or any portion of Tenant's security deposit is applied by Landlord during the term of this Lease, Landlord may demand that Tenant replenish the full amount applied. Tenant's failure to replenish the amount

within seven (7) days after written demand will constitute a breach of this Lease. The balance of all deposits shall be refunded no later than twenty-one (21) calendar days from the date possession of the Leased Premises is delivered to Landlord or Landlord's agent, together with a statement showing any charges made against the deposits by Landlord.

#### Section 15. Waiver

No failure of Landlord to enforce any term of this Lease shall be deemed a waiver, nor shall any acceptance of a partial payment of rent be deemed a waiver of Landlord's right to the full amount of rent.

#### **Section 16. Notices**

Any notice that either party may or is required to give, may be given by mailing the notice, postage prepaid at the address shown below, or at any other place designated in writing by the parties from time to time.

#### Section 17. Successors and Assigns

This Lease is binding upon and inures to the benefit of the heirs, assigns, successors, executors, and administrators of Landlord and Tenant.

#### Section 18. Time

Time is of the essence in this Lease

#### Section 19. Holding Over

Any holding over after expiration of the Lease, with the consent of Landlord, shall be construed as a month-to-month tenancy in accordance with the terms of this Lease, as applicable. No holding over or extension of this Lease shall extend the time for the exercise of the option unless agreed upon in writing by Landlord.

#### Section 20. Late Charges

If Tenant fails to pay the Monthly Rent within five (5) days after the due date, Tenant agrees that it would be impracticable or extremely difficult to fix the actual damage to Landlord caused by

that failure and therefore agrees to pay a late charge of [amount]. The amounts due under this Section are in addition to and not in lieu of any other remedies of Landlord.

#### **Section 21. Construction**

Headings at the beginning of each section of this Lease are solely for the convenience of the parties and are not a part of and shall not be used to interpret this Lease. The singular form shall include plural, and vice versa. This Lease shall not be construed as if it had been prepared by one of the parties, but rather as if both parties have prepared it. Unless otherwise indicated, all references to sections are to this Lease.

#### Section 22. Further Assurances

Whenever requested to do so by the other party, each party shall execute, acknowledge, and deliver any further conveyances, agreements, confirmations, satisfactions, releases, powers of attorney, instruments of further assurance, approvals, consents, and any further instruments and documents as may be necessary, expedient, or proper to complete any conveyances, transfers, sales, and agreements contemplated by this Lease. Each party also agrees to do any other acts and to execute, acknowledge, and deliver any documents reasonably requested to carry out the intent and purpose of this Lease.

#### Section 23. Third Party Rights

Nothing in this Lease, express or implied, is intended to confer upon any person, other than the parties and their respective successors and permitted assigns, any rights or remedies under or by reason of this Lease. Tenant shall not assign this Lease without Landlord's advance written approval.

#### Section 24. Counterparts

This Lease may be executed in one or more counterparts, each of which shall be deemed an original and all of which taken together shall constitute one and the same instrument.

#### Section 25. Amendment

This Lease may not be amended or altered except by an instrument in writing executed by Landlord and Tenant.

#### Section 26. Partial Invalidity

1. Parties—USA Technologies, Inc. (USAT), I	per the effective date herein, hereby agrees to provide to ("Customer") cashless

- 2. Cashless Transaction Processing & Associated Fees—USAT shall act as and is hereby appointed the agent on behalf of Customer in connection with the processing of all card transactions (authorized and settled) by the payment processor or other private network in connection with the Customer's Equipment. USAT shall retain a processing fee consisting of a percentage or a processing fee of a percentage + a set dollar amount per transaction of the gross sales price, for all card revenues derived from the Equipment. All processing fees charged to Customer, as selected by Customer, are predicated upon processor or private network authorized and settled transactions, and *not* from third party controllers providing DEX data or other forms of M2M data. See *Schedule A Fees*. The net revenues (gross revenues less refunds, transaction processing fees, any consumer refund and/or chargeback fees from the card processor and/or fraudulent transactions or any other fee due to USAT hereunder) shall be remitted to Customer by USAT.
- **3. PrePaid Card Programs**—Additional transaction and service fees may apply for the implementation and use of prepaid cards on the USAT network. The net revenues (gross revenues less refunds, prepaid transaction processing fees, any consumer chargeback and/or chargeback fees and/or fraudulent transactions or any other fee due to USAT hereunder) shall be remitted to Customer by USAT.
- **4. Network & Services Fees**—The Customer shall pay to USAT a monthly fee per activated device or system connected to the USAT processing network for Wireless or Ethernet communications, web-based cashless transaction reporting, financial/accounting transaction services, and customer support services. *See Schedule A—Fees.* If optional M2M data transport such as CASH or DEX exceeds the monthly kilobytes within the stated price plans, Customer will be automatically moved to the next wireless data plan.
- **5. Seasonal Equipment**—If the Customer's business (whole or in part) is of a seasonal nature whereby the Equipment will not be in use for at least four consecutive months, the Customer may elect to <u>deactivate</u> some or all affected Equipment for that time period. The monthly network fee may be adjusted for each seasonally designated cashless device or system connected to the USAT processing network. *See Schedule A—Fees.* The Customer will receive a one-time adjusted payment (credit) at the time of <u>reactivation</u> of the seasonally affected Equipment during the following month remittance to Customer by USAT.
- **6. Registration and Fees**—USAT will charge Customer at the time of shipment or at time of transfer of ownership to Customer. USAT will include on the invoice, an initial fee to register each device or system installed and linked to the USAT processing network. See Schedule A—Fees. This may include but is not limited to the registration of a SIM card required to establish wireless communications or an Ethernet connection, in addition to administrative setup for Customer to receive weekly EFT payments, Merchant ID assignment, and access to USALive web reporting.
- **7. UnRegistration, ReRegistration, and Fees**—The Customer may choose to unregister the SIM card or system, which stops all communications with the USAT processing network, at no charge. However, if the customer decides to re-register a SIM card or system, a re-registration fee is required. *See Schedule A—Fees*.
- **8. Device Default Settings**—All ePorts will be shipped to Customer with the following device <u>default</u> settings: (a) Single-Vend ON; (b) Multi-Vend OFF; (c) Cash OFF and (d) DEX OFF.
- 9. SIM Cards—All SIM cards remain the property of USAT and must be returned to USAT upon termination of this services agreement for any reason.

- 10. Device Location Assignment—After the Wireless or Ethernet card acceptance device is installed into Customer's Equipment. Customer should use USALive to update the device location for proper identification. USALive has the ability to accept a spreadsheet using the Mass Update function or individually update each ePort device installed in the field. If this function is performed by USA Technologies a fee may be applied for each device updated. Improper location assignment could result in higher chargeback activity.
- 11. Pre-Authorization—Customer agrees for all cashless transactions, every card will be submitted to the card processor for card validation and transaction authorization.
- 12. Settlement—Customer agrees that for any transaction during the settlement process that is subsequently declined by the card processor for non-sufficient funds (NSF) or other reasons, the risk of the associated loss of vended product, settlement funds and transaction fee for that transaction shall be assumed by the Customer.
- 13. Proprietary Software—Customer acknowledges and agrees that the computer programs, computer software, specifications, data, images, designs, codes, configurations, ("Software") contained in or utilized by the Equipment and USAT's USALive® network are proprietary and confidential to USAT and protected under United States copyright law. Customer shall not copy, modify, adopt, translate, merge, reverse engineer, decompile, or disassemble, the equipment or Software, or create any derivative works based on the Equipment, USALive® network or Software.
- 14. Term—The term of this Agreement shall be for a period of thirty-six (36) months effective on the effective date of this agreement. The Agreement will automatically renew for one (1) year, unless thirty (30) day written notice has been provided to USAT by Customer.
- 15. Termination—Customer may choose to terminate its USAT ePort Connect Services agreement on all of its Customer-owned equipment with a written thirty (30) day notice. The termination of this Agreement by the Customer shall not affect any equipment LEASE agreement relating to an e-Port between Customer and USAT which shall remain in full force and effect in accordance with the terms provided within the LEASE agreement.
- 16. Availability of Service—Customer acknowledges that USAT relies on third-party providers in the delivery of its services, including, but not limited to, wireless data network providers, cellular radio service provided by third parties that is available only when within the operating range of cellular systems, and cellular service is subject to transmissions limitations and dropped or interrupted transmissions. Cellular service may be temporarily refused, limited, interrupted, or curtailed because of government regulations or orders, atmospheric and/or topographical conditions, and cellular system modifications, repairs, and upgrades. Customer agrees that USAT shall not be liable for, and to hold USAT harmless for any losses, damages, or business interruptions sustained as a result of interruptions caused by its wireless data network providers or any other third-party provider.
- 17. No Consequential Damages—In no event shall USAT be liable for any punitive, incidental, or consequential damages or any damages for loss of profits, business interruption, loss of information, or pecuniary loss, even if such party has been advised of the possibility of such damages.
- 18. Indemnification—Each party shall indemnify and hold harmless the other party, its officers, directors, agents, and employees from and against any and all claims, demands, causes of action, obligations, liabilities, expense (including reasonable attorney's fees), damages, or suits whatsoever, in connection with, arising out of, or relating to, in whole or in part, any act or omission of Customer, including, but not limited to, the operation and management of the Equipment.
- 19. Validity—Should any part of this Agreement, for any reason, be declared invalid, then such portion shall be invalid only to the extent of the prohibition without invalidating or affecting the remaining provisions of the Current Customer and USAT Agreement. This agreement shall be constructed in accordance with the laws of the State of Pennsylvania exclusive of any conflicts of law principles.

### **HVAC MAINTENANCE AGREEMENT**

This Agreement is entered into between Taft City School District ("TCSD") and West Kern Community College District ("WKCCD"), both of Kern County California.

### **RECITALS**

- A. The parties are both public school agencies.
- B. WKCCD has the capacity, and is willing, to provide services as specified below to TCSD on the terms and conditions outlined in this Agreement.
- C. WKCCD will serve as the agency by whose powers this joint exercise of powers is exercised.

### **TERMS**

- 1. WKCCD will, to the extent feasible after having first met its own needs for the services described below:
  - A. Inspect, service and repair heating, ventilation, and air conditioning systems owned or leased by TCSD, to the same standards as apply to WKCCD's own equipment, including all standards required by law.
  - B. Invoice TCSD on a monthly basis.

## 1. TCSD will:

- A. Pay promptly, after receipt of monthly invoices as follows:
  - 1. WKCCD's certified cost for parts and supplies (such as lubricants).
  - 2. Labor charges at \$67.00 per hour, with a minimum ½ hour charge for work performed on any equipment.
  - 3. Services will be provided at TCSD's facilities. However, WKCCD agrees that, to the extent its employees are required to enter TCSD's school sites to perform services under this Agreement, WKCCD employees will be under the direct supervision of TCSD employees at all times and will comply with TCSD's directions reasonably designated to insure that WKCCD employees will have limited contact with TCSD's pupils and to insure the safety of TCSD's pupils while they are on TCSD sides.

4. The term of this Agreement is July 1, 2018 through June 30, 2019. Either party may terminate this Agreement on 30 days' written notice to the other, delivered to their respective district offices.

Investments were held at these two institutions as part of the Districts General Obligation Bonds and/or Certificate of Participation (COP) Notes Program. This provided an investment vehicle for WKCCD to be used in conjunction with its construction programs and building on campus. This information is being submitted for informational purposes only.

#### Fiscal Impact Including Source of Funds (if applicable):

The <u>U.S. Bank Global Corporate Trust Services</u> accounts had a beginning balance of \$1,896,613 at July 1, 2017, and an ending balance of \$1,896,731 for its Certificates of Participation accounts. This balance represents the 2015 COP reserve portion that is designated for the District's debt obligation repayment.

The <u>Bank of New York Mellon</u> had a beginning and ending balance of \$0.02 in the account is tied to the District's general obligation bonds for the period that ended in 2016-17. The remaining balance represents excess interest accrued during the transition for final payoff for the escrow account being housed at BNY.
